



### Ivory Coast

### Council Implementing Regulation (EU) No 949/2011

This notification is issued in respect of the restrictive measures directed by the Council of the European Union in view of the situation in the Ivory Coast.

1. With the publication of Council Implementing Regulation (EU) No 949/2011 of 22 September 2011 in the Official Journal of the European Union (O.J. L247, 24.9.2011, P.1) on 24 September 2011, the Council has removed thirteen individuals from Annex IA to Council Regulation (EC) No 560/2005 ("the 2005 Regulation"), with effect from 24 September 2011.
2. Annex IA to the 2005 Regulation lists persons and entities covered by the freezing of funds and economic resources imposed under Article 2 of that Regulation.
3. The individuals removed from Annex IA are therefore no longer subject to the asset freeze imposed under Article 2 of the 2005 Regulation. Details of the individuals removed are set out in the Annex to this notification.
4. The Treasury's Consolidated List of persons subject to financial sanctions in effect in the UK which is maintained on the Treasury website has been updated to reflect the deletions.
