

## **Financial Sanctions Notification**

# Libya

# Council Implementing Regulation (EU) No 502/2011

This notification is issued in respect of the asset-freezing measures directed by the Council of the European Union against certain persons in view of the situation in Libya.

- With the publication of Council Implementing Regulation (EU) No 502/2011 of 23 May 2011
  ["Regulation 502/2011"] in the Official Journal of the European Union (O.J. L136, 24.5.2011,
  P.24) on 24 May 2011, the Council of the European Union has added one individual and one
  entity to Annex III to Council Regulation (EU) No 204/2011 ["Regulation 204/2011"], with
  effect from 24 May 2011.
- 2. Annex III to Regulation 204/2011 lists persons, entities and bodies designated by the Council.
- 3. The individual and entity added to Annex III are therefore subject to the asset freeze imposed by Regulation 204/2011.
- 4. Details of the additions are set out in the Annex to this notification.
- 5. The Treasury's Consolidated List of individuals and entities subject to financial sanctions in effect in the UK, which is maintained on the Treasury website, has been updated to reflect the additions.

#### Reporting requirements

7. Relevant institutions and other persons are requested to check whether they maintain any accounts or otherwise hold any funds or economic resources for the persons added by Regulation 502/2011 to Annex III to Regulation 204/2011, and, if so, they must freeze such accounts or other funds and, unless licensed by the Treasury, refrain from making available funds and/or economic resources to such persons.

8. Relevant institutions must report their findings to the Treasury, together with any additional information that would facilitate compliance with Regulation 204/2011.
