

Financial Sanctions Notification

Ivory Coast

Council Implementing Regulation (EU) No 419/2011

This notification is issued in respect of the restrictive measures directed by the European Union against certain persons and entities in view of the situation in the Ivory Coast.

- With the publication of Council Implementing Regulation (EU) No 419/2011 ("Regulation 419/2011") of 29 April 2011 in the Official Journal of the European Union (O.J. L111, 30.4.2011, P.1) on 30 April 2011, the Council of the European Union has removed six entities from Annex IA to Council Regulation (EC) No 560/2005 ("the 2005 Regulation"), with effect from 30 April 2011.

- 3. Annex IA to the 2005 Regulation lists the natural or legal persons, entities or bodies who have been identified by the Council of the European Union and are therefore subject to the freezing of funds and economic resources provisions imposed under Article 2 of the 2005 Regulation.
- 4. The six entities removed from Annex IA are therefore no longer subject to the asset freezes imposed under the 2005 Regulation.
- 5. Details of the entities removed from Annex IA are set out in the Annex to this notification.
- 6. The UK's Consolidated List of individuals and entities subject to financial sanctions in effect in the UK which is maintained on the Treasury website has been updated to reflect the deletions.
